# SHAKA EASTER SOCCER TOURNAMENT NPC 2026, 6<sup>TH</sup> EDITION

## 1. ADMINISTRATIVE AND TECHNICAL RULES

1.1 The tournament will be played for **12 days** across all divisions from **Saturday the 07<sup>th</sup> of March 2026** to **Monday the 06<sup>th</sup> of April 2026**.

- **Week 1** : Saturday the 07<sup>th</sup> and Sunday the 08<sup>th</sup> March 2026
- **Week 2** : Saturday the 14<sup>th</sup> and Sunday the 15<sup>th</sup> March 2026
- **Week 3** : Saturday the 21<sup>st</sup> and Sunday the 22<sup>nd</sup> March 2026
- **Week 4** : Saturday the 28<sup>th</sup> and Sunday the 29<sup>th</sup> March 2026
- **Week 5** : Friday the 03<sup>rd</sup>, Saturday the 04<sup>th</sup> & Sunday the 05<sup>th</sup> of April 2026.
  
- **NB.:** : Monday the 06<sup>th</sup> of April 2026 (standby date)

1.2 The tournament will be played on a knockout system across all divisions.

1.2.1 Similarly, the games for Senior divisions will be played in knockout system however they will be divided into 4 groups which will consist of 16 teams per group.

1.2.2 Top 2 teams in each group will progress to the Quarter Final round.

1.2.3 Top 2 teams per group will be determined as follows: Overall Goal difference, Goal Scored and Goal Against (Excluding penalties shootout) also disciplinary based on Yellow and Red cards.

1.3 All games must produce the winner as per fixture. (In regulation time).

1.4 Should there be a tie in a game, penalty shootouts will be used to determine the ultimate winner.

### 3. PLAYER'S EQUIPMENTS AND SOCCER JERSEYS/KITS

3.1 Junior divisions and Women division will be allowed to use their own team soccer jerseys during their first round/ stage games which are as follows;

- Under 13 : Last 16 games
- Under 15 : Last 08 games
- Under 17 : Last 16 games
- Women/Ladies : Last 16 games

**3.1.1 Both Open and Masters divisions will be allowed to use their own team soccer jerseys during their first round and second round stage games which are as follows;**

- **Masters : Last 32 and Last 16 games**
- **Open : Last 64 and Last 32 games**

3.2 Therefore, all the **Winners (52 teams)** will receive sponsored branded soccer jerseys/kits that must be utilized for the duration of the tournament, as per the below table.

3.3 Teams are advised and encouraged not to wear their owned sponsored jerseys that could be in competition with tournament sponsors. **Eg Vodacom vs MTN.** (All affiliated and registered teams will be alerted of our entire tournament's sponsors to avoid conflict of sponsorships).

3.4 All sponsored teams must alert the tournament organizing committee and apply in writing for permission to have their sponsorship branding items during the tournament.

3.5 Disciplinary measures will be taken against any teams who do not use the soccer kits provided to them.

## 5. TEAM'S REGISTRATION AND TEAM LISTS

5.1 All teams that meet requirements of **Shaka Easter Soccer Tournament 2026, 6<sup>th</sup> Edition** will be allowed to register and to participate in **Shaka Easter Soccer Tournament NPC (SEST) 2026**.

5.2 Any South African based football team is allowed to participate in **Shaka Easter Soccer Tournament NPC 2026** except **Premier Soccer League - PSL (Betway League), Motsepe Foundation Championship League (National First Division League - NFD)** and **Hollywoodbets Women's Super (SAFA Women's League)** teams.

5.2.1 In an event whereby a team wishes to register a professional individual player from the leagues indicated above, a team will be restricted to register a maximum of 8 players and only utilize 4 players in the field of play during the entire game.

5.3 Note Well: The participating teams may register players from above-mentioned leagues.

5.4 The registration of players and technical officials will resume on **MONDAY** the **02<sup>nd</sup>** of **FEBRUARY 2026** at **00H00 AM** and close on **FRIDAY** the **20<sup>th</sup>** of **FEBRUARY 2026** at **23H59 PM**.

5.5 The teams in the **MASTER, OPEN/SENIOR DIVISIONS, UNDER 13,15, 17** and **WOMEN DIVISIONS** are limited to register **25 players** and **5 officials** during the tournament.

5.6 Teams will only be allowed to register additional or replace players after the first round games have been concluded.

5.7 The following fees for addition and replacement of players will be incurred as outlined in table 5.8

5.9 Player(s) additions or replacements must be submitted in writing to the SEST NPC Administrator, bg1@mh.org.za or agosatong@gmail.com or via WhatsApp to 0727522538. The Tournament organizers will regularly also continuously communicate the closing date for the additions and replacement of players on a weekly basis. The replacement document letter must be on team letterhead and accompanied by proof of payment, made into the SEST NPC banking account. (FNB - 62913412764) Failure to comply with the procedure may result in the additions/replacement being rejected.

5.10 No player will be allowed to participate, if he/she does not appear on the **MASTER TEAM REGISTRATION FORM** as well as in **MATCH TEAM SHEET** that will be issued by tournament officials.

5.11 Team Sheet Form will be typed and all registered players and officials will be listed on the form.

5.12 Team Managers will only be allowed to **mark and write jerseys numbers** (using a pen) of **starting eleven and 9 substitutes players** (*No handwriting Team Sheet Form will be allowed during the entire tournament and if happened both two team managers will be updated by tournament's match convener*).

**5.13 Three (3) team sheets must be completed and return to tournament's match convener 60 minutes before start of the game. FAILURE TO ADHERE/COMPLY WILL RESULT IN A FINE OF R 2000.00 FOR SENIORS AND MASTERS CATEGORY HOWEVER FOR U13, U15, U17 ALSO WOMEN CATEGORY IT WILL BE 350.00. FINES MUST BE PAID BEFORE MATCH KICK-OFF OR FORFEITING THE MATCH.**

5.14 Players will not be allowed to **register with more than one team or switch from one team to another during SEST's Tournament** as this will result in **disciplinary measures taken against the team concerned and subsequently forfeiting the match.**

5.15 The tournament committee's decision as to eligibility of a player shall be final and not subject to appeal.

5.16 Foreign player(s) must have valid original passport identity documents.

### 7 **MATCH RULES FOR ALL DIVISIONS**

7.1 **Fixture, Date, Venue and Time of the match** will be determined by the Tournament Committee and make a determination on the sequence of games to be played for all divisions.

7.2 All teams must arrive to match venue at least **2 hours/120 minutes before kick-off** for logistics and match administration. Any team that arrives late to their game will be fined an amount of **R1000.00 to be paid prior to kick-off.**

7.3 Each team shall have **three (3) opportunities**, including half time break to make a **maximum of five (5) substitutions** during the game.

7.4 Team officials must be fully registered on **Master Team Registration Form** and will be issued with the accredited card reflecting their designations.

7.5 **Nine (9) substitutes** and **five (5) officials** will be permitted on the technical area during match, per team. (Only total of maximum **14 team members** will be allowed to sit on the technical area)

7.6 **Teams are expected to be on the field 15 minutes prior to kickoff for ID/Valid Passport and players' equipment verification/checks. NO TEAM/PLAYER WILL BE ALLOWED TO PLAY WITHOUT VERIFICATION**

7.7 During the game, each team shall warm up on their side of technical area and not more than five (5) players shall warm up a time.

7.8 **Team's players who wish to wear undergarments, they are welcome to do so, provided that players of the same team wear the similar colour of undergarments irrespective of their soccer Kits.**

7.9 **NO PLAYER WILL BE ALLOWED TO PLAY WITHOUT SOCCER BOOTS AND SHIN-PADS**

### 8 **DISPUTES**

8.1 Any disputes that may arise during the tournament will be resolved by tournament Disciplinary Committee appointed by the tournament organizers

8.2 Disputes will be resolved **72 hours** after the dispute was lodged.

8.3 **Any misconduct by players, coaches or team officials will result in the disqualification of the set player, official or the team in general.**

- 8.4 Protest fee will be **R 8 000.00** for open division and appeal will be **R 10 000.00**
- 8.5 Whilst protest fee for all other categories will be **R 3 000.00** and appeal fee will be **R 4 000.00**
- 8.6 **Red carded player** will serve a **one match suspension**. Player/team official who get sent off during the last game of the Tournament will automatically serve suspension in the next SEST edition regardless of any team registered for.
- 8.7 In terms of yellow cards, a **player who accumulate 3 yellow cards during the Tournament will serve a match suspension**
- 8.8 **Referee decision shall be final at all matches.**
- 8.9 **Teams will be alerted or informed in cases where there is alleged suspended player or official prior to each game (All suspended player(s) will be updated on Team Player Sheet List)**

## 9 **PROTEST'S MATTERS**

- 9.1 All teams must be discipline and control their players and supporters during the match
- 9.2 All protests and complaints relating to the eligibility of a player (suspension etc.) to play in any given match must be lodged with the Tournament Disciplinary Committee prior to the match. Notwithstanding this, the Disciplinary Committee may take disciplinary action against any club fielding a player who is not eligible to play in a match, such team shall forfeit the match and not progress to next round.
- 9.3 Any other complaint or suggestions must be put on writing and submitted at the tournament office. This also include complaint about the referee(s) as this matter will be opened for discussions during the tournament committee daily meetings during the tournament. (depending on the nature of complaint, all complainants will receive responses before their next match takes places)
- 9.4 All other protests or complaints may be made in writing at any time as soon as the incident or contravention of the rules is discovered and must be done before conclusion of the game in question.
- 9.5 Protest must in the first instance be lodged with the referee on the fields of play at the time of the violation-taking place, prior to the completion of the match. Tournament Representative must be immediately notified if the game is played under protest.**
- 9.6 Protesting team must pay a protest fee, during the presentation of the protest letter to the Tournament Representative before a hearing takes place. Such fee is refundable only if the protesting team wins the case and therefore the guilty team must pay the cost of hearing that will be determined by Disciplinary Committee.

## 10 **FIRST AID AND MEDICAL SERVICES**
